**Limited Entries:** Entries may not exceed 7 hours of judging per judge.

Entries open at 8:00 AM on Sunday, June 1, 2025

**Entries close at 5:00 PM on Friday, July 18, 2025.** After the entries close, entries cannot be accepted, canceled, or substituted except as provided for in Chapter 14, Section 6 of the AKC Dog Show Rules.

**How to Enter:** Go to <a href="www.gsdcgw.org">www.gsdcgw.org</a>, scroll down and click on Show & Trial Premiums; find the tile for the AKC Obedience & Rally Trial 2025 August and click OPEN button. When the page opens, the Premium will load in a document window that will allow you to print. To enter the Trial, click

# **Important Trial Information**

**JUMP HEIGHT:** Dogs will compete **"TALL TO SMALL"** in all rings for all classes. **Don't forget** to indicate your jump height on the entry form in the space provided. Entries that require a jump height, that are received lacking a jump height, will be returned as an incomplete entry.

**UDX ENTRIES**: Please check the box on the entry form for UDX. Dogs entered in this class will be entered in both Open B and Utility B. Once the limit has been reached in any class, all subsequent entries will be returned in their entirety.

**RAE ENTRIES:** Please check the box on the entry form for RAE. Dogs entered in this class will be entered in both Rally Advanced B and Rally Excellent B. Once the limit has been reached in any class, all subsequent entries will be returned in their entirety.

**RAEM ENTRIES**: Please check the box on the entry form for RAEM. Dogs entered in this class will be entered in Rally Advanced B, Rally Excellent B, and Rally Master. Once the limit has been reached in any class, all subsequent entries will be returned in their entirety.

**Order of Entry Acceptance, Option 2:** We will accept entries for German Shepherd Dogs <u>first</u> and then accept entries from all other breeds and All-American dogs listed in the AKC Canine Partners program until the entry limit specified is reached (in the order that they are received). GSDCGW reserves the right to increase the number of entries in any class to reach the 7-hour judging limitation.

**High Combined/High in Trial:** Only dogs entered in regular obedience classes will be eligible for High Combined or High in Trial Rosettes and/or Prizes. Only dogs entered in Rally classes will be eligible for High Combined Rosettes and/or Prizes.

**Crating:** There will be crating in Building 6822 and Building 6826.

#### OTHER IMPORTANT TRIAL RULES/REGULATIONS/INFORMATION

- The judges are not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called.
- No children under 18 will be permitted at these trials or on the trial grounds unless showing a dog.
- Your dog must be on a six foot or shorter leash when outside the CTA building exercising your dog. No flexible leashes will be allowed. Pick up after your dog and dispose in can in the exercise area.

- Lunch will be on your own for all exhibitors. Handlers who wish food for themselves or their dogs must bring it with them and clean up afterwards.
- GSDCGW reserves the right to cancel this trial at any time. Should that happen, any checks for trial entry fees will be shredded and credit will be issued to those who paid online.
- There is no smoking in either building.
- Please dispose of trash in the proper manner.



**CLOSING DATE** for entries is <u>Friday</u>, <u>July 18</u>, <u>2025</u>, <u>at 5:00 PM</u>, after which, entries cannot be accepted, cancelled, or substituted except as provided for in Chapter 14, Section 5 of the AKC Dog Show Rules.

**TRIAL HOURS**: The Obedience and Rally Trials will be open from 8:30 AM to 6:00 PM.

**ACKNOWLEDGEMENT OF ENTRIES** will be made as soon as practicable via email if email addresses are provided and legible. Should the exhibitor not receive such acknowledgment within a reasonable time, please notify the Trial Secretary, Gayle Griffin, by email at purplepaws1@gmail.com.

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.

**RETURNED CHECKS** do not constitute a valid entry fee. The trial secretary will add a collection fee of \$30.00 to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being placed on a cash only basis.

**REFUNDS:** Entry fees shall not be refunded in the event a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of the Trial Committee. No refunds will be made for bitches in season after the closing date. If because of riots, civil disturbances, or other acts beyond the control of management, it is impossible to open or to complete the trial, no refund of entry fees will be made.

**ERRORS ON ENTRY FORMS:** Owners are responsible for errors on entry forms, either written or online, whoever may make such errors, and no entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date.

**ARRIVAL:** Dogs may arrive prior to their scheduled time of judging. Dogs not required for further judging will be excused. Judge will not wait for any dog holding up a class. All dogs must be held on a leash or confined to their crates except when being judged or when in the ring.

**RISK**: The owner or agent entering a dog in an Obedience or Rally trial does so at his/her own risk and agrees to abide by all the Rules and Regulations of the American Kennel Club.
